Advocates for Youth

Independent providers at small, community-based clinics provide 2/3 of the abortions in the USA. This organization

works to keep these clinics open and helps them mobilize on social media and within their communities so that they can continue providing care and education to those in need of contraception and/or abortions. They also work to end harassment at and outside abortion clinics to decrease the incidence of anti-choice violence and to ensure all women have access to dignified reproductive care.

Center For Reproductive Rights

The Center works in U.S. states to implement reproductive rights policy initiatives and strategies that improve access to abortion care and prevent restrictions. It works closely with the United Nations across five countries to protect women's bodies. In addition to defending women's reproductive justice and access to safe abortions, they also support obstetrics care, maternal and natal care, contraception access, and they fight against forced sterilization and child marriage.
